THIS INDENTURE Made and entered into this 30th day of September 1929 by and between Monroe Vallett, a single man, party of the first part, and Constantine Famelos and Alice M. Famelos, husband and wife, parties of the second part, Witnesseth;

That the party of the first part for and in consideration of the sum of one dollar to him in hand paid, does hereby grant, bargain, sell and convey unto the said parties of the second part the following described real property situate in Skamania County, State of Washington, to-wit:

Commencing at a point 31.47 chains east of the southwest corner of the north half of the H. Shepard Donation Land Claim, said corner being 15.75 chains east and 20.97 chains north of the quarter corner to section 1 tp 2 N R 7 E. W. M. and section 36 tp 3 N R 7 E. W. M., thence N 17°07' W 24.52 chains; thence East 21.33 chains; thence S 17°07' E 24.52 chains; thence West 21.33 chains to the place of beginning.

Also: Commencing at the same point of beginning as the above described; thence in a southeasterly direction along the bed of a small creek  $3\frac{1}{2}$  chains to the north line of the
