That there were three children the issue of the marriage between said Charles E. Yettick and Margaret Yettick,one of which died prior to the death of said Charles E. Yettick.That the said Charles E.Yettick died in the year 1906 leaving surviving him as his sole heirs at law his said widow,Margaret,and two minor children,Erma Inez and Charles Merle,who are the same persons named in the guardianship matter of Erma Inez Yettick and Charles Merle Yettick,had in the Superior Court of the State of Washington for Skamania County.That there was no probate of the estate of said Charles E.Yettick,who died intestate
