EDNA ARNOLD TO BYRON ARNOLD

KNOWAALL MEN BY THESE PRESENTS, That I, Edna Arnold, an unmarried woman, of Portland, Oregon, in consideration of Ten Dollars, to me paid by Byron Arnold do hereby grant, bargain, sell and convey unto said Byron Arnold his heirs and assigns, all the following real property, with the tenements, hereditaments and appurtenances, situated in the County of Skamania and State of Washington bounded and described as follows, to-wit:

COMMENCING At a point sixty-eight (68), feet south of the North East Corner of the North West Quarter of the North East Quarter of Section thirty-four (34), in Township Two (2), North of Range Six (6) East of the Willamette Meridian, which Point is in the center of the County Road, known as the Skelton Road; thence following the center line of said Skelton Road, in a Westerly direction, Six Hundred Thirty, (630) Feet; Thence continuing along the center line of said Skelton Road in a southerly direction, a distance of Five Hundred Fifty (550) Feet; Thence East Two Hundred Twenty (220) Feet to the center of the County Road known as the Butler Road; Thence following the center line of said Butler Road in a South Easterly direction, One Hundred ninety two (192) feet to the intersection with the East line of the North West Quarter of the North East Quarter of said Section Thirty Four (34) Thence North to the place of beginning, containing six (6) Acres more or less, subject to easement of said roads.

To Have and to Hold, the above described and granted premises unto the said Byron Arnold
his heirs and assigns forever.

And I the grantor above named do covenant to and with the above named grantee his heirs and assigns that I am lawfully seized in fee simple of the above granted premises, that the above granted premises are free from all incumbrances save and except a mortgage for Three Hundred Dollars, which the grantee assumes and agrees to pay as part consideration herein, and that I will and my heirs, executors and administrators, shall warrant and forever defend the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever, except the mortgages described above.
