The West half of the northeast quarter ($W\frac{1}{2}$ of NE $\frac{1}{4}$) and the west half of the southeast quarter ($W\frac{1}{2}$ of SE $\frac{1}{4}$) of Section twenty-two (22) of Township three (3) North of Range nine (9) East of the Willamette Meridian, together with all and singular the tenements, hereditaments and appurtenances thereto belonging or in anywise appertaining, and also all estate, right, title and interest in and to the same, including dower and claim of dower.
