THIS INDENTURE WITNESSETH, That Ernest Haussman, and Christina Haussman, who were at the time they acquired the hereinafter described real property and now are husband and wife parties of the first part, for and in consideration of the sum of one Dollars, in lawful money of the United States of America, to them in hand paid by Herman S. Doetsch and Lillian P. Doetsch, his wife parties of the second part, have GRANTED, BARGAINED and SOLD, and by these presents do Grant, Bargain, Sell and Convey unto the said parties of the second part, and to their heirs, and assigns, the following described real property, situate, lying and being in the County of Skamania, State of Washington, to-wit:

The West one half ( $W\frac{1}{2}$ ) of that part of the Northeast quarter ( $NE\frac{1}{4}$ ) of the Northwest quarter ( $NW\frac{1}{4}$ ) of Section thirty-five (35) Township two (2) North of Range Six (6) East of the Willamette Meridian which lies north of the north line of the right of way of State Road No. 8 containing 18  $11/100$  acres more or less.

TO HAVE AND TO HOLD, The said premises, with all their appurtenances, unto the said parties of the second part and to their heirs and assigns forever; and the said Ernest Haussman and Christina Haussman parties of the first part, for themselves and for their heirs, executors and administrators, do hereby covenant to and with the said parties of the second part their heirs and assigns, that they are the owners in fee simple of said premises, and that they are free from all incumbrances whatsoever and that they will WARRANT and DEFEND the title thereto against all lawful claims whatsoever,
