KNOW ALL MEN BY THESE PRESENTS, That CHARLES D. BOWLES and ALMEDA T. BOWLES, his wife, of the city of Seattle, state of Washington, in consideration of One (\$1) Dollar to them paid by J. R. Bowles of the city of Portland, state of Oregon, have bargained and sold, and by these presents do grant, bargain, sell and convey unto said J. R. Bowles, his heirs and assigns, an undivided one-half interest in and to all the following bounded and described parcels of real property, situated in the county of Skamania and state of Washington:

Parcel 1:

The Southwest quarter (SW $\frac{1}{4}$ ) of Section Twenty-six (26) Township Two (2) North, Range five (5) East of Willamette Meridian, containing one hundred and sixty (160) acres more or less.

Parcel 2:

The Southeast quarter of Section 27th, Township 2 North, Range 5 East of Willamette Meridian, containing 160 acres.

Parcel 3:

The Southwest quarter of the Southwest quarter of Section numbered fourteen (14), and the southeast quarter of the southeast quarter of Section numbered fifteen (15), and the west half of the northwest quarter of Section numbered twenty-three (23) all in Township numbered (2) North, Range five (5) East of Willamette Meridian, containing one hundred sixty (160) acres.

Parcel 4:

Southwest quarter of Section numbered twenty-three (23) in Township numbered two (2) North, Range numbered five (5) East of Willamette Meridian.

Parcel 5:

The south half of the northwest quarter and the fractional north half of the northwest quarter of Section numbered twenty-six (26) in Township numbered two (2) North Range numbered five (5) East of Willamette Meridian, excepting that part of said northwest quarter lying west of the center of the Washougal River.

Parcel 6:

The East half of the Southeast quarter, and the East half of the Northeast quarter of Section twenty-two (22) in Township two (2) North Range five (5) East of Willamette Meridian.

Parcel 7:

The East half (E $\frac{1}{2}$ ) of the northeast quarter (NE $\frac{1}{4}$ ) of the northeast quarter (NE $\frac{1}{4}$ ) of Section twenty-seven (27), Township two (2) north, Range five (5) east of Willamette Meridian.
