WITNESSETH, That whereas, at a public sale of real property, held on the 31st day of August, 1929, pursuant to an order of the Board of County Commissioners of Skamania County State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale as required by the Laws of the State of Washington, the sum of Five Hundred Dollars was the highest bid received at the aforesaid sale, for the following described real property, to-wit:
