Each of the andersigned hereby authorizes the Bank: (1) To date this note as of the day when the loan evidenced hereby is made; (2) Fix the date on which payments are to begin; (3) Cause the signature(s) of one or more co-makers, in addition to the original number, to be added at any time or times hereto, and to do so with or without notice to any of the undersigned, who hereby consent thereto and acknowledge that such may be done without affecting the joint and several obligation of each of the undersigned, as hereinbefore set forth.
