This Deed, made this eleventh day of February 1930, by and between Standard Investment Company party of the first part; and the United States of America, party of the second part.

WITNESSETH: That whereas the said party of the first part has filed its application for exchange of certain lands with the United States, under the terms of the Act of Congress of March 20, 1922, entitled, "An Act to Consolidate National Forest Lands,"-vol. 42, United States at Large, page 465; and

WHEREAS, an application has been submitted by the party of the first part to the Secretary of the Interior to exchange the tracts hereinafter described for timber on the Columbia National Forest, in accordance with the said Act of Congress:
