ORDER OF SOLVENCY

This cause coming on to be heard on the petition of C. E. Bingham and N. P. Nelson, the executors of the above entitled estate, for an order of solvency, and it appearing to this court that the said inventories show that the value of the property of the said estate is \$12,310.00 and from the said inventories and from the evidence adduced upon this hearing it appears that the total amount of the debts, costs and expenses of administration amount to the sum of \$1984.75 and it further appearing that a stipulation has been entered into between the State of Washington Board of Tax Commissioners and the said estate that the inheritance tax due to the State of Washington from the said estate amounts to the sum of \$179.70 and that the said inheritance tax has been paid as provided by law.

It is therefore hereby Ordered: Adjudged and Decreed that the above estate is fully solvent and that the will of the deceased which has been admitted to probate in this court provides that this estate may be managed and settled without intervention or interference of any court or courts whatsoever.

And it is further ordered, Adjudged and Decreed that any and all liens of the State of
