C O P Y LAST WILL AND TESTAMENT OF HANNAH ROSS

In The Name of God Amen: I Hannah Ross of Sedro Wooley Skagit County, Washington, having reached and long since passed the age of majority and being of sound and disposing mind and memory and not acting under duress, menace, fraud or undue influence of any person, do make, publish and declare this my last Will and Testament, in the manner following:

First: I direct that all my just debts and funeral expenses be paid so soon after my death as can conveniently be done.

Second: I hereby Give, Grant Will and devise and bequeath unto my beloved husband, David Ross, a life estate in and to all of the Real Property that I now own or may hereinafter acquire in the State of California, and also all of the Real Property that I now own or may hereinafter acquire in the County of King, State of Washington, and at his death the said property to be equally divided among my hereinafter named relatives to wit:

Unto My beloved sister Ann Johnson, a One Sixth Interest, Unto Olga Johnson, my neice and the daughter of the said Ann Johnson a One sixth interest unto John Anderson my nephew being the same who visited me in Sedro Woolley Washington, now living at Portland, Oregon, a one sixth interest.

Unto the Father of my said Nephew John Anderson a One sixth Interest and unto the sisters of my said Nephew John Anderson, Anna and Carrie who were formerly Anna and Carrie Anderson, But who have since married and their marriage name is unknown to me each a one sixth interest.

Third: Unto C. E. Bigham and Company a corporation, of Sedro Wooley, Washington I give and bequeath the sum of One Thousand Dollars, to be held in trust, the interest from the said One Thousand Dollars to be applied to the payment of the taxes on the property herein devised unto my beloved husband during his life time and at his death to be divided as provided in Section "FIFTH: hereof

Fourth: All the Real Property now owned or hereafter acquired by me in Skamania County, Washington and also all real estate in Skagit County State of Washington owned by me including the Home in which my husband and I now reside I do hereby give and bequeath unto my beloved husband David Ross

Fifth: All the rest residue and remainder of my Estate, Real, Personal and mixed, separate or community I hereby give, devise and bequeath unto my hereinafter named relatives as follows to wit: Unto my Beloved sister Ann Johnson a One Sixth Interest, unto Olga Johnston, my Neice, and the daughter of the said Ann Johnson, a One sixth interest, unto John Anderson My nephew, being the same who visited me in Sedro Woolley Wash, now living at Portland, Oregon, a one sixth interest, unto the father of my said nephew John Anderson a One sixth interest and unto the sisters of my said nephew, Anna and Carrie who were formerly Anna and Carrie Anderson but who have since married and their marriage name is unknown to me each a One-sixth interest.

Sixth:

I hereby name, nominate and appoint C. E. Bigham and N. P. Nelson of Sedro Wooley, Washington as executors of this my Last Will and Testament to serve without Bonds and direct that this my my last Will and testament be settled in the manner herein provided and that letters testamentary or of administration shall not be required and that my estate be managed and settled without the intervention of any court, and I do hereby grant unto my said executors herein before named or either of them who shall serve, full and complete
