W. M. containing 40 acres, according to Government Survey. Also all right, title and interest of the Grantors in a certain, a right of way 20 feet wide, a part of and along the North line of the Southwest quarter of the northeast quarter of said Section, until a County Road shall be established to the North half of the above.
