STEVENSON WATER COMPANY to TOWN OF STEVENSON

THIS INDENTURE made this 24th day of March, 1929, by and between the Stevenson Water Company, a corporation, party of the first part, and Town of Stevenson, a municipal corporation, party of the second part Witnesseth:

That the party of the first part for and in consideration of the sum of One Dollar to it hand paid by the party of the second part, and pursuant to a resolution of the Board of Trustees authorized and ratified by the stockholders of said Stevenson Water Company duly made and entered in the record of its minutes, said party of the first part does hereby Grant, Bargain, Sell, and Convey unto the party of the second part, its successors and assigns, the following described real and personal property in Skamania County, Washington:

The water system supplying the inhabitants of the Town of Stevenson and vicinity with water owned and operated by the party of the first part, including all intakes, together with impounding reservoir thereat, main pipe lines and easments therefor, distribution pipe lines and private easements therefor, reservoirs and reservoir sites, franchises and grants by the County of Skamania and Town of Stevenson, water rights and water appropriations perfected or being perfected or acquired by the party of the first part, all pipes, fittings, tools, equipment and other personal property owned by said party of the first part, save and except cash on hand and accounts outstanding.
