A. E. GIPSON ET UX TO Alice E. Gipson

Gipson, his wife of Caldwell County of Canyon State of Idaho the parties of the first part, and Alice E. Gipson, of St. Charles County of St. Charles State of Missouri the party of the second part.

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of Eleven Hundred and no/100 - - - - -DOLLARS, lawful money of the United States of America, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, have granted, bargained and sold, and by these presents do grant, bargain, sell, convey and confirm unto the said party of the second part, and to her heirs and assigns forever, all the following described real estate, situated in, County of Skamania, State of Washington to-wit:

The West One-half (W $\frac{1}{2}$) of the Northwest Quarter (NW $\frac{1}{4}$) and the West One-half (W $\frac{1}{2}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section Twenty, (20) in Township Two (2) North of Range Six (6) East of the Willamette Meridian, containing one hundred and sixty (160) acres.
