THIS INDENTURE, Made this 10th day of September in the year of our Lord one thousand nine hundred and forty-five BETWEEN Leonard Foster and Ruby J. Foster, husband and wife parties of the first part and Sam Angelo (two-third interest) and Louis Angelo (one-third interest) parties of the second part:

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of SIX THOUSAND and no/100-----Dollars, lawful money of the United States, to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, do by these presents, Grant, Bargain, Sell, Convey and Warrant unto the said parties of the second part, and to their heirs and assigns, the following described tract or parcel of land, lying and being in the county of Skamania, and State of Washington, and particularly bounded and described as follows, to-wit:

The northerly 60 feet of Lots 7 and 8, Block 5, Riverview Addition to the Town of Stevenson, excepting that part (if any) lying easterly of the easterly wall of the concrete garage building on said lots. Also three pumps, one air compressor, and hydraulic hoist which are permanent fixtures attached to said property.

together with all and singular the tenements, hereditaments and appurtenances thereunto belonging.

THIS CONVEYANCE is intended as a MORTGAGE to secure the payment of SIX THOUSAND and no/100 Dollars, lawful money of the United States, together with interest thereon at the rate of seven per cent per annum from date until paid, according to the terms and conditions of one certain promissory note, bearing date September 10th, 1945, made by the parties of the first part payable on or before five years after date to the order of the parties of the second part and these presents shall be void if such payment be made according to the terms and conditions thereof. But in case default be made in the payment of the principal or interest of said promissory note, or any part
