C. W. Clarke et ux to Standard Investment Co.

THIS INDENTURE made and entered into this 10th day of August 1911, by and between C. W. Clarke of the city and County of San Francisco, State of California, the party of the first part, and Standard Investment Company, a corporation organized and existing under the laws of the State of California, the party of the second part, Witnesseth;

That Whereas, by an Act of Congress, approved June 4th, 1897, (30 Stat. 36) it is provided:

"That in cases in which a tract covered by a patent is included with"in the limits of a public forest reservation, the owner thereof may, if he de "sires to do so, relinquish the tract to the Government, and may select in lieu thereof a "tract of vacant land open to settle...tn,"etc.

And Whereas, the said party of the first part was the owner of the following described land, to-wit:

Now, Therefore, Know All Men by These Presents, that for value Received the receipt whereof is hereoyacknowledged, the said party of the first part does hereby Crant, Bargain, Sell, Convey and Confirm unto Standard Investment Company, its successors and assigns forever, all of the right, title and interest that the said party of the first part now owns, holds, possesses and claims and also all of the right, title and interest that said party of the first part may hereafter acquire by virtue of said selection, of, in and too the said selected land which is described as follows, to-wit: That certain tract of land situated in the County of Skamania, State of Washington and described as follows, to-wit:
