MORTGAGE

THIS MORTGAGE, Made this _____ day of _____ 1945 by Hugh F. Hall and Sigrid D. Hall, husband and wife herein called the Mortgagors, and W. M. Nail and Nolia Nail, husband and wife herein called the Mortgagees, WITNESSETH:

The Mortgagors, in order to secure payment to the Mortgagees of a debt of ONE THOUSAND FOUR HUNDRED and no/100 ----- (\$1400.00) Dollars, and interest and all other sums as provided herein, and the performance of all covenants herein contained, do hereby grant and convey to the Mortgagees that certain real property, with the appurtenant tenements, hereditaments and privileges, and all fixtures for heating, lighting and water with which the premises are equipped and may be equipped, situated in the County of Skamania and State of Washington and legally described as follows, to-wit:

Beginning at the Northeast corner of the Northeast quarter of the Southeast quarter of the Northeast quarter of Section One (1) Township Three (3) North, Range seven and one half (7½) East of the Willamette Meridian, thence east of the east line of Lot four (4) of Section six (6) Township three (3) North, Range eight (8) East of the W. M. thence south, thence west, thence north on the west line of lots five (5) and four (4) to point of beginning, all of said lines being of sufficient length to form a rectangular field containing twenty-five (25) acres; Also the Northeast quarter of the Southeast quarter of the Northeast quarter of Section One, township three North, Range 7½, East of the Willamette Meridian.
