THIS INDENTURE, Made this 28th day of October, 1929, between A. C. Sly, as Treasurer of Skamania County, State of Washington, the party of the first part, and V. W. Harshbarger of Carson, Wash., party of the second part;

WITNESSETH, THAT WHEREAS, at a public sale of real property held on the 23rd day of June A.D. 1928, pursuant to an order of the Board of County Commissioners of the County of Skamania, State of Washington, duly made and entered, and after having first given due notice of the time and place and terms of said sale; and,

WHEREAS, in pursuance of said order of the said Board of County Commissioners, and of the Laws of the State of Washington, and for and in consideration of the sum of Twenty Dollars, lawful money of the United States of America, to me in hand paid, the receipt whereof is hereby acknowledged, I have this day sold to V. Harshbarger, his heirs and assigns forever, the said real property hereinbefore described, as fully and completely as the said party of the first part can by virtue of the premises convey the same.
