KNOW ALL MEN BY THESE PRESENTS, That Marie Feustel & Wm. Feustel, her husband, both of the City of Portland, Multnomah County, Oregon, in consideration of Ten (\$10.00) Dollars and other good and valuable considerations to them in hand paid by Elmer W. Means of the City of Portland, Multnomah County, Oregon, have bargained and sold and by these presents do grant, bargain, sell and convey unto said Elmer W. Means, his heirs and assigns, all the following bounded and described real property, situate, lying and being in the County of Skamania, State of Washington, to-wit:

The Southwest quarter (SW $\frac{1}{4}$) of the Southwest quarter (SW $\frac{1}{4}$) of the Northwest quarter (NW $\frac{1}{4}$) of Section Thirty-four (34) Township Two (2) North, Range Six (6) East of the Willamette Meridian, containing Ten (10) Acres more or less, together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in any wise appertaining, and also all our estate, right, title and interest in and to the same.

TO HAVE AND TO HOLD, the above described and granted premises unto the said Elmer W. Means, his heirs and assigns forever. And Marie Feustel, Grantor above named, does covenant to and with Elmer W. Means, the said above named Grantee, his heirs and assigns, that she is lawfully seized in fee simple of the above granted premises, that the above granted premises and free from all incumbrances, except a certain mortgage executed by William T.
