Quitclaim Deed

THIS INDENTURE, Made this 28th day of August in the year of our Lord one thousand nine hundred and thirty between B. M. Hawley and May M. Hawley, his wife of Oreana County of Owyhee State of Idaho, the parties of the first part, and School District No. 10 Consolidated of Skamania County, Washington of County of Skamania State of Washington, the party of the second part.

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of One Hundred Twenty and No/100 (\$120.00) Dollars, lawful money of the United States of America, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents remise, release and forever QUITCLAIM, unto the said party of the second part, and to its heirs and assigns, all that certain lot, piece or parcel of land, situate, lying and being in County of Skamania, State of Washington, bounded and particularly described as follows, to-wit:

Beginning at the NE corner of Lot No. 8 according to plat of Home Valley, Washington, as surveyed by E. F. Sharp and recorded in the County Clerk's office in Book A of Plats on Page 26 of Skamania Co. records, running thence west (124) one hundred twenty-four feet; thence South (300) three hundred feet; thence east (104) One Hundred Four Feet; thence South (281.5) Two Hundred Eight-one and one-half feet; thence east (20) twenty feet; thence North (581.5) Five Hundred Eighty-one and one-half feet to place of beginning.

TOGETHER With all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, the reversion and reversions, remainder and remainders, rents, issues and profits thereof.
