Warranty Deed

One (1) North of Range Five (5) East of the W. M. Running thence along the East line of southwest quarter Sixteen (16) rods and Ten (10) feet, being along the County Road; Thence Northwesterly along the County Road Eighty-three (83) Rods to a point at which the former private road known as the Marrin & Didier Road now a County Road, intersects the said County Road;
