For the purpose of erecting, maintaining and operating thereon one pole of a pole line for the transmission of Electric current.

Pole to be approximately 340 feet west of east line of property and approx. 45 feet <sup>not</sup> of center line of State Highway together with the right to cut, remove and destroy such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage.
