IN CONSIDERATION OF ONE AND no/100 DOLLARS (1.00) the receipt whereof is hereby acknowledged the undersigned R.T. Strong and Martha W. Strong, husband and wife grant to Northwestern Electric Company a Washington corporation, a perpetual right of way in and over the following described real property situated in the county of Skamania State of Washington, to-wit: west half of the south west quarter of section thirty four, Township two north, range six east of the Willamett Meridian, for the purpose of erecting, maintaining and operating thereon two poles and four anchors of a pole line for the transmission of electric current, and for no other purpose. The number and location of said poles and anchors shall be :- Pole No 1 to be about 500 ft east of the west line and 102 ft north of the center line of State Highway; Pole No 2 to be 400 ft farther east and about 125 ft north of the center line of State Highway. Anchor No 1. to be at turn of Maple Flat Road No 2 will be about 150 ft north and about 5 ft west of Maple Flat county Road, No. 3 will be about 150 ft further north and about 7 ft west of county road
