For the purpose of erecting maintaining and operating thereon three poles <sup>and</sup> one anchor of a pole line for the transmission of electric current. Poles to be approx 400 ft apart and 45 ft north of the center line of the State Highway. One anchor to be approx 15 north of pole near east line of property. together with the right to cut, remove and destroy such trees and brush as may be necessary in constructing, maintaining and protecting such line from damage.
