Pole 178 to be approx 140 ft east of the county road at west of property, and pole 179 to be 350 ft east of pole 178; pole 180 to be 350 ft east of pole 179; pole 181 to be 350 ft east of pole 180. All poles to be approx. 45 ft north of the center line of State Hwy.

The company to be responsible for any damage done to stock or property should line break down at any time, together with the right to cut, remove and destroy such trees and brush as may be necessary in constructing, maintaining and protecting such lines from damage.
