One anchor to be approx 400 ft east of the half section line of section 1 and approx. 65 ft north of State Highway center line,also one anchor approx. 200 ft west of the west line of the S.E. $\frac{1}{4}$ of S.E. $\frac{1}{4}$ of section 1 and approx 65 ft from the center line of the State Highway,together with the right to cut,remove and destroy such trees and brush as may be necessary in constructing maintaining and protecting such line from damage.
