THIS INDENTURE, Made this 14 day of January in the year of our Lord one thousand nine hundred and forty-six BETWEEN Frank E. Voorhees and Alice E. Voorhees, husband and wife, parties of the first part, and Bank of Stevenson party of the second part:

WITNESSETH, That the said parties of the first part, for and in consideration of the sum of FOUR THOUSAND and no/100 DOLLARS, lawful money of the United States, to them in hand paid by the said party of the second part, the receipt whereof is hereby acknowledged, do by these presents, Grant, Bargain, Sell, Convey and Warrant unto the said party of the second part, and to its heirs and assigns, the following described tract or parcel of land, lying and being in the County of Skamania, and State of Washington, and particularly bounded and described as follows, to-wit:

Beginning at a point on the Northerly line of the Evergreen Highway which is North 79° 51' West 458.35 feet from a point on said Northerly line which is 1052.00 feet South and 915.68 feet West of the Northeast corner of Section 21 in Township 2 North of Range 7 East of the Willamette Meridian and running thence North 79° 51' West, along said Northerly line 101.85 feet; thence North 0° 48' West 200 feet; thence South 79° 51' East parallel to said Northerly line of said highway, 101.85 feet; thence South 0° 48' East 200 feet to the point of beginning, said tract being designated as Lots 10, 11, 12, and 13, Block 10 of the unrecorded plat of the Town of North Bonneville, Skamania County, RESERVING therefrom the right to lay and maintain water main on South line thereof.
