Sly,as treasurer of Skamania County,State of Washington,the party of the first part  
and E.E.Book of Carson Wash. party of the second part;

WITNESSETH THAT WHEREAS,at a public sale of real property held on the 4th day  
of October A.D.1930,pursuant to an order of the Board of County Commissioners of the  
County of Skamania State of Washington,duly made and entered,after first given due  
notice of the time and place and terms of said sale,and  
WHEREAS,in pursuance of said order of the said board of county commissioners and of the  
Laws of the State of Washington,and for and in consideration of the sum of Ten Dollars
