of real estate held on the 4th day of October, A.D. 1930, pursuant to a real estate tax  
judgement entered in the Superior court of the County of Skamania on the 23rd day of Sep-  
tember A.D. 1930 in proceedings to foreclose a tax lien upon real estate and an order of sale  
duly issued by said court, A.C.Hitchman duly purchased in compliance of the laws of the
