Ralph Lighthill to Francis Lighthill

KNOW ALL MEN BY THESE PRESENTS, that Ralph Lighthill in consideration of Ten and no/100 dollars to him paid by Francis Lighthill does hereby grant, bargain, sell and convey unto said Francis Lighthill, her heirs and assigns, all the following real property, with the tenements, hereditaments and appertenances, situated in the County of Skamania and State of Washington, bounded and described as follows, to-wit:

Beginning at the southwest corner of the northeast quarter of section 2, township 2 north, range 7 East of the Willamett Meridian, said point being on the north line of the Baughman D.L.C., thence running east 550 feet, thence north to the south line of the original state road survey made by Murry in 1906 and 1907, thence southwesterly on the said original State Road survey to the point of beginning, containing about two acres.

To Have and to hold, the above described and granted premises unto the said Francis Lighthill, her heirs and assigns forever.

And the grantor above named does covenant to and with the above named grantee her heirs and assigns that he is lawfully seized in fee simple of the above granted premises, that the above granted premises are free from all incumbrances, and that he will and his heirs, executors and administrators, shall warrant and forever defend the above granted premises, and every part and parcel thereof, against the lawful claims and demands of all persons whomsoever.
