Also that certain mining claim designated and known as Jim No.12 Quartz Mining claim and takes the north part of Oh Boy Quartz claim now forfeited and abandoned, balance is virgin ground. Legth of cāaim covers Camp Creek and jions Jim No.11 on the northwest and on the head of camp creek, said claim as located being 1500 linear feet horizontal measurement on the strike of lode, vein, ledge or deposit, along the vein thereof, with all its dips, spurs angles and variations as allowed by law, together with 300 feet on each side of the middle of said claim at the surface ground within the lines of said claim.
