Also that certain mining claim designated and known as The Oh Bill Quartz Mining claim, as shown by the original notice thereof properly posted upon said claim and filed in the office of the Auditor of Skamania County, Washington, on July 13, 1929, and recorded in book F of Mining locations at page 417, said claim as located being 1500 linear feet horizontal measurement on the strike of lode, vein, ledge or deposit, along the vein thereof with all dips, spurs, angles and variations as allowed by law, together with 300 feet on each side of the middle of said vein at the surface grounds within the lines of said claim.

Also that certain mining claim designated and known as The Juniper Quartz Mining claim, as shown by the original notice thereof properly posted upon said claim and filed in the office of the Auditor of Skamania County, Washington, on July 13, 1929, and recorded in book F of Mining locations at page 416, said claim as located being 1500 linear feet horizontal measurement on the strike of lode, vein, ledge or deposit, along the vein thereof with all dips, spurs, angles and variations as allowed by law, together with 300 feet on each side of the middle of said vein at the surface grounds within the lines of said claim.

Also that certain mining claim designated and known as the Short Mining Quartz, or Lode claim, as shown by the original notice thereof properly posted upon said claim and filed in the office of the Auditor of Skamania County, Washington, on August 1, 1930, at 11:30 O'Clock in the forenoon of said day, and recorded in book F of mining locations at page 515, said claim as located being 1500 linear feet horizontal measurement on the strike of lode, vein, ledge or deposit, along the vein thereof, with all its dips, spurs, angles and variations, as allowed by law, together with 300 feet on each side of the middle of said vein at the surface ground within the lines of said claim.

That certain mining claim designated and known as Eva No. 8 Quartz Claim Location, as shown by the original notice thereof properly posted upon said claim, being a claim 1500 linear feet horizontal measurement on the strike of lode, vein, ledge or deposit, along the vein thereof with all dips spurs angles and variations as allowed by law together with 300 feet on East side and 300 feet on the west side of the middle of said vein at the surface so far as can be determined from present developments, and all veins, lodes, ledges or deposits and surface ground within the lines of said claim, 300 linear feet, running east from this discovery post, said discovery post being situated upon said lode, vein or deposit and within the lines of said claim in Niggerhead Mining District, Skamania County, Washington. The aforesaid claim takes in the North one-half of the Spokane Quartz Claim now forfeited and abandoned, and crosses Dry Gulch some 900 feet east of McCoy Creek.

Also that certain mining claim known and heretofore designated as Orrell Quartz, or Lode Claim, as shown by the original notice thereof posted upon said claim and filed in the office of the Auditor of Skamania County, Washington, on September 25, 1929, at 8:45 o'clock in the forenoon on said day and recorded in Book F of Mining Claims at page 423. Said claim is located 1500 linear feet and horizontal measurements on the strike of lode, vein, ledge or deposit along the vein thereof, with all its dips, spurs, angles and variations, as allowed by law, together with 300 feet on each side of the middle of said vein at surface ground within the lines of said claim.
