IN THE MATTER OF STATE ROAD NO. 8 Stevenson to Wind River

Know all men by these presents, That Christian Aalvik and Anna Aalvik his wife, of the County of Skamania in the State of Washington, in consideration of the benefits and other valuable considerations, and the sum of Two Hundred Dollars, in hand paid, the receipt whereof is hereby acknowledged have GRANTED, BARGAIN, SOLD and CONVEYED, and by these presents do Grant, Bargain, Sell and Convey unto the State of Washington, the following described parcel of land situated in Skamania County, in the State of Washington, to-wit:

A strip of land 80 feet wide, being 80 feet on the northerly side and of the center of said road as surveyed over and across a tract of land in the Henry Shepard Donation Land Claim Twp. 3 North Range 7 $\frac{1}{2}$ East W. M. bounded on the northerly side by the south line of Stevenson Park Addition to the Town of Stevenson on the west by Kanaka Creek on the South by State Road No. 8 and on the East by Strawberry Road and known as Tax Lot 95C

And also grant to the said State of Washington the right to take material consisting of sand gravel and earth from an additional strip land 175 feet wide adjoining and contiguous to said aforementioned strip of land for the purposes of maintenance and construction, the right to operate equipment thereon and the right of ingress and egress for the purpose of removing material therefrom from date herein to January 1st, 1932.

As a further consideration said State of Washington shall remove said material to a uniform grade.

The grantors herein reserve the right to any timber that may be cut in the course of the said State of Washington's operations.

the specific details concerning all of which are to be found within that certain map of definite location now of record and on file in the office of the Director of Highways at Olympia and bearing date of approval May 18th, 1925 revised September 27th, 1930.
