Carl A. Kapp et al to Henry Kapp

THIS INDENTURE WITNESSETH, That Carl A. Kapp, Henrietta Kapp Godfrey and Julia Kapp Slutz being children of Christiana Kapp and Heinrich Kapp, the latter sometimes known as Henry Kapp, (husband and wife) and both deceased, parties of the first part, for and in consideration of the sum of One Dollar and other valuable consideration, lawful money of the United States of America, to them in hand paid by Henry Kapp, our Brother party of the second part do by these presents remise, release, convey and quit claim unto said party of the second part his heirs and assigns, all interest of the said parties of the first part in and to the following described real property, situated in Skamania County, State of Washington, to-wit: Deed H. 556-All that portion of sec. 15, Twp. 3 N. R. 10, E. W. M. commencing at the interior quarter section corner in said section 15; thence north 49 rods; thence west 49 rods; thence south 49 rods; thence east 49 rods to place of beginning, containing 15 acres more or less.

Deed T 41.-All of lot 19 and the east 12 feet of lot 18 in block 1, First Addition to Town of Underwood according to the official plat thereof as recorded at page 19 Book A of Plats, records of Skamania County, Washington  
Deed V 127-

Lot 7 of block 2 of first addition to town of Underwood as shown by the official plat thereof on file in the office of the Auditor for Skamania County, Washington..

Deed V 201- Lot 5 of block 2 of first addition to Town of Underwood as shown by the official plat thereof in the office of the Auditor for Skamania County, Washington.

Deed V 476-Lot 3 of block 1 of town of Underwood as shown by the official plat thereof on file in the office of the Auditor for Skamania County, Washington.

Deed V 475-Beginning at a point from which the corner of sections 14, 15, 22 and 23 T. 3 N. R. 10 E. W. M., bears N 89° 48' E 1327.6 feet distant, said point being the middle of the south line of the SE  $\frac{1}{4}$  of sec. 15 aforesaid; thence northward 660 feet along the line common to the SW  $\frac{1}{4}$  and the SE  $\frac{1}{4}$  of SE  $\frac{1}{4}$  of said section 15; thence westward 198 feet on line parallel to the south line of said quarter section; thence southward 660 feet to the south line of said quarter section; thence eastward 198 feet to point of beginning, containing 3 acres more or less; saving and excepting therefrom a strip of land 7  $\frac{1}{2}$  feet in width along the east side of said tract, reserved for road

Also conveying and quitclaiming to said Henry Kapp all our right, title, interest and estate in and to all personal property belonging to the estate of our deceased parents, together with their interest in all business in which either or both of them were engaged at the time of their demise.
