This Indenture, Made this 30th day of June, 1930 between A. P. Gordon, Sheriff of the County of Skamania, State of Washington, party of the first part, and J. Brandes and Addie Brandes, husband and wife of the County of \_\_\_\_\_\_ State of Oregon parties of the second part, witnesseth;

That, Thereas, By virtue of a general execution issued out of and under the seal of the Superior Court of the State of Washington, in and for said County, on the 28th day of May, 1929, upon a judgment rendered in said Court in Gause No. 1842 on the 28th day of May, 1930, in favor of J. Brandes and Addie Brandes, husband and wife and against J. W.
