Relinquishment

The United States of America, To all to whom these presents shall come, Greeting:

Whereas, Charles H. Leadbetter, Jr., and wife, Lessie Leadbetter, relinquished to the United States the land hereinafter described as a basis for a forest lieu selection under the act of June 4, 1897 (30 Stat. 36), which selection was finally canceled on May 27, 1905; and

Whereas, Section 6 of the act of April 28, 1930 (Public No. 174 - 71st Congress), provides "that where a conveyance of land has been made or may hereafter be made to the United States in connection with an application for amendment of a patented entry or entries, for an exchange of lands or for any other purpose, and the application in connection with which the conveyance was made is thereafter withdrawn or rejected, the Commissioner of the General Land Office is hereby authorized and directed, if the deed of conveyance has been recorded, to execute a quitclaim deed of the conveyed land to the party or parties entitled thereto":

Now, Therefore, the Commissioner of the General Land Office does hereby remise, relinquish and quitclaim to Charles H. Leadbetter, Jr., his heirs or assigns, all title to said land which the United States may have acquired by virtue of that certain deed executed by Charles H. Leadbetter, Jr., and Lessie Leadbetter, his wife, on the twenty-ninth day of December, in the year of our Lord, One Thousand Nine Hundred and recorded on the fourteenth day of January, in the year of our Lord, One Thousand Nine Hundred and One, in Book G of Deeds, page 205, Deed records of Skamania County, Washington, for land described as follows:

Lots 2, 3, 6, 7 and 11 Sec. 2, T. 4 N. R. 9 E., W. M., Washington, containing 154.55 acres.

In Testimony Hereof, I, C. C. Moore, Commissioner of the General Land Office of the United States of America, have caused these letters of relinquishment to be executed and the seal of the General Land Office to be hereunto affixed.
