TIS INDENTURE made this 8th day of December A.D.1928 between A.C.Sly as Treasurer of Skamania County, State of Washington, party of the first part and F.T.Blaisdell party of the second part, WITNESSETH, That whereas, at a public sale of real estate held on the 8th day of December A.D.1928, pursuant to a real estate tax judgement entered in the Superior Court in the County of Skamania on the 26th day of November A.D 1928, in proceeding to foreclose tax lien upon real estate and an order of sale duly issued by said court F.T.Blaisdell duly purchased in compliance with the laws of the State of Washington, the following described real estate to-wit:
