This Indenture made this 14th day of March, A. D. 1931 between A. C. Sly, as Treasurer of Skamania County, State of Washington, party of the first part, and Edward Hollis party of the second part:

Witnesseth, That, whereas, at a public sale of real estate held on the 14th day of March, A. D. 1931, pursuant to a real estate tax judgment entered in the Superior Court in the County of Skamania on the 20th day of February, A. D. 1931, in proceedings to foreclose tax liens upon real estate and an order of sale duly issued by said court, Edward Hollis duly purchased in compliance with the laws of the State of Washington, the following de-
scribed real estate, to-wit:
