Warranty Deed

The Grantors;- Richard J. Hill, whose name appears as grantee in that certain deed dated September 2, 1930 and recorded in Book "W" of Deeds at page 464 thereof, records of Skamania County, Washington as Richard J. Hill, and Signa Hill (husband and wife) both of Berkeley, County of Alameda, State of California, for and in consideration of the sum of Ten (\$10.00) Dollars, in hand paid, the receipt of which is hereby acknowledged, CONVEY and WARRANT to Emma Hill, the Grantee, the following described real estate:

Commencing at the southeast corner of the southwest quarter of section six (6) Township one (1) north of Range five (5) East of the W. M., running thence north along the East line of the southwest quarter sixteen (16) rods and ten (10) feet, being along the County Road; thence northwesterly along the county road eighty three (83) rods to a point at which the former private road known as the Marrin & Didier Road, now a County Road, intersects the said County Road; thence south westerly and following the said private road, now a county road, thirty-six (36) rods to a point on the south line of said section six (6), which point is one hundred one (101) rods and six (6) feet west of the southeast corner of the southwest quarter of section six (6); thence east along the south line of said section six (6) one hundred one (101) rods and six (6) feet to the place of beginning, containing 12-7/8 acres more or less.
