to Pacific Power & Light Company, a corporation, its successors and assigns, an easement or right-of-way for an electric transmission and distributing line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and including the right to place all said lines in underground conduits) at or near the location and along the general course now located and staked out by the Grantee over, across and upon the following described premises, located in Skamania County, Washington to-wit:

Southwest quarter of the Northeast quarter (SW $\frac{1}{4}$ of NE $\frac{1}{4}$), the southeast quarter of the northwest quarter (SE $\frac{1}{4}$ of NW $\frac{1}{4}$), Lot three (3) in the northeast quarter of the southwest quarter (NE $\frac{1}{4}$ of SW $\frac{1}{4}$) and Lot Two (2) in the Northwest quarter of the southeast Quarter (NW $\frac{1}{4}$ of SE $\frac{1}{4}$) Section Twenty-six (26) Township three (3) North Range Nine (9) East, Willamette Meridian.

Together with the right of ingress and egress over the adjacent lands of the Grantors for the purpose of constructing, reconstructing, stringing new wires on, maintaining and removing said lines and appurtenances, and exercising other rights hereby granted.

All rights hereunder shall cease when said lines have been abandoned.

The Grantors Rosa Walther Zulauf and George Zulauf, her husband of Skamania County, Washington, for and in consideration of Twenty and no/100 (20.00) Dollars, in hand paid, CONVEY and WARRANT to Pacific Power & Light Company, a corporation, its successors and assigns an easement or right-of-way for an electric transmission and distributing line of one or more wires and all necessary or desirable appurtenances (including telephone and telegraph wires, towers, poles, props, guys and other supports and including the right to place all said lines in underground conduits) at or near the location and along the general course now located and staked out by the Grantee over, across and upon the following described premises, located in Skamania County, Washington to-wit:

The southeast quarter (SE $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section twenty-four (24) township 3 North, range 9 east, Willamette Meridian and the northwest quarter (NW $\frac{1}{4}$) of the Northwest quarter (NW $\frac{1}{4}$) of Section twenty-five (25), township 3 North range 9 East, Willamette Meridian.
