All that part of Lot 5, section 31, township 3 North, range 9 east W. M., north of the Seattle, Portland and Spokane Railway Co's right of way between a line at right angles to the tangent of center line of said road at survey station 170+50 and the east line of said lot 5, lying southerly of a line 80 feet northerly of and parallel to the center line of said road.
