

# DEED RECORD W

## SKAMANIA COUNTY, WASHINGTON

PARCEL 15: The northwest quarter of the northwest quarter of section 20, township 2 north of range 5 East of Willamett Meridian, in Skamania County Washington .

PARCEL 16: Lot 8 in block 56 in that part of the city of Vancouver lying west of Main street, as laid out and platted by Esther Short, in Vancouver, Clark County, Washington.

PARCEL 17: Lots 1 and 2, block 49, in that part of the city of Vancouver, Clark County, Washington, lying west of Main street and south of 9th street as laid out and platted by Esther Short.

PARCEL 18: Lots 3 and 4, block 49, in that part of the city of Vancouver, Clark County Washington, lying west of Main street and south of ninth street as laid out and platted by Esther Short.

PARCEL 19: All of block 29 in that part of the city of Vancouver, Clark County, Washington, lying west of main street as laid out and platted by Esther Short.

PARCEL 20: All that part of lots 2, 3, 4, 5, 6, 7 and 8 block 45, of west Vancouver (in the city of Vancouver, Clark County, Washington) according to the duly recorded plat thereof) which lies southwesterly of a line drawn parallel with and distant 50 feet southwesterly from when measured at right angles to the center line of the main track of railroad of the Spokane, Portland and Seattle Railway Company, as the same is now constructed.

PARCEL 21: All of <sup>numbered</sup> lot 7 of block 56 of that part of the city of Vancouver, Clark County Washington, lying west of main street <sup>as</sup> originally laid off and platted by Esther Short, according to the duly recorded plat thereof.

PARCEL 22: All of lots 5 and 6 in block 49 in that part of the city of Vancouver, Clark County, Washington, lying west of main street and south of ninth street, as laid out and platted by Esther Short.

PARCEL 23: All that portion of lot 3, block 37, west Vancouver, in the city of Vancouver Clark County, Washington, according to the duly recorded plat thereof, described as follows: beginning at a point on the east line of said lot 3 distant 50 feet south of the northeast corner thereof; thence north along the east line of said lot a distance of 7.07 feet; thence northwesterly in a straight line 60.7 feet to a point on the north line of said lots which is distant 7.07 feet east of the northwest corner thereof; thence west 7.07 feet to the northwest corner of said lots; thence southeasterly in a straight line 70.7 feet to the point of beginning, containing an area of 329 square feet more or less.

PARCEL 24: All that portion of lot 3, block 37, west Vancouver, in the city of Vancouver, Clark County, Washington, according to the duly recorded plat thereof, described as follows: beginning at a point on the east line of lot 3 distant 50 feet south from the northeast corner of said lot; thence south to the southeast corner thereof; thence west to the southwest corner thereof; thence north to the northwest corner thereof; thence southeasterly on a straight line to the place of beginning.

PARCEL 25: All of lots 7 and 8 of block 49 of that part of the city of Vancouver, Clark County, Washington, as laid out and platted by Esther Short.

PARCEL 26: Lots 5 and 6 of block 56 in that part of the said city of Vancouver, Clark County, Washington, lying west of main street, as laid out and platted by Esther Short.

PARCEL 27: Beginning at a point 30 feet west of the east line and 15.18 feet south of the north line, of lot 4, as originally platted in block 37 of West Vancouver, of the City of Vancouver, Clark County, Washington, and running thence south on a line parallel with and thirty feet from the east line of said lot 4 and the east line of lot 5 of said block 37, to the north line of the public levee; thence south 61°34' east on said north line of Levee, to the east line of said lot 5; thence north on said east line of
