## REAL ESTATE MORTGAGE

THIS MORTGAGE, made this 11th day of July, 1947, by and between RAYMOND L. BACHMAN and ELEANOR M. BACHMAN, husband and wife of Vancouver, County of Clark, State of Washington, hereinafter called "mortgagor(s)," and THE NATIONAL BANK OF COMMERCE OF SEATTLE, a national banking association, hereinafter called "Mortgagee,"

## WITNESSETH

The mortgagors hereby mortgage to the mortgagee, its successors and assigns, the following described real property, situated in the County of Skamania, State of Washington, to-wit:

Beginning at a point 300 ft. West more or less to a witness tree under which an iron stake is set from the East side of the 20 acre tract of land conveyed to J. E. Snyder by John H. Morgan on May 10, 1911, and recorded in Book N of Deeds page 154, Skamania County Deed record, where the State road crosses the said East line of the above described 20 acre tract of land; running thence South from said witness tree to the center of the Washougal River and thence up the center of the Washougal River to the Southeast corner of the 20 acre tract of land conveyed to Snyder on May 10, 1911, and thence along the east line of said 20 acre tract to a point where the State road crosses said 20 acre tract and thence West following State road 300 feet more or less to the witness tree above described, and being the point of beginning and containing 12 acres of land more or less situated in Section 31, Township 2 North of Range 5, East of the Willamette Meridian, Skamania County, Washington.

TOGETHER with all right and interest therein, now owned or hereafter acquired, and all and singular the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, including, but not limited to, all heating, plumbing, lighting and ventilating apparatus, appliances or fixtures in or about any building now located on said premises or hereafter place thereon, together with any and all removals, betterments, additions or substitutions thereto, all of which said apparatus, appliances or fixtures are deemed by and between the parties hereto to constitute a part of the realty.
