Larsen and Mary Larsen, who were at the time they acquired title to the property herein described, and now are, husband and wife, parties of the first part, and Phillip Aaron Larsen, party of the second part, witnesseth:

that for and in consideration of the sum of One Dollar and other considerations the parties of the first part do hereby CONVEY and WARRANT unto the said party of the second part, his heirs and assigns, the following described real property in Skamania County, Washington, to-wit:

Commencing at the point of intersection of the north line of the County road as now constructed through Lot 2 Section 21, Tp. 3 N. R. 10 E. W. M. with the east line of said Section 21, thence north along said section line 90 feet, more or less, to the small creek, thence southwesterly along the said creek to the north line of said county road, thence easterly 100 feet, more or less, along the north line of said road to the point of beginning.
