er of Skamania County, State of Washington, party of the first part, and the County of  
Skamania State of Washington, party of the second part:

Witnesseth, That, Whereas, pursuant to a real estate tax judgment entered in the Sup-  
erior Court of the County of Skamania State of Washington, on the 4th day of September, A.  
D. 1931, in proceedings to foreclose tax liens upon real estate, wherein the said county of  
Skamania State of Washington, was given a several judgment against each of the pieces, par-
