Now at this time coming on to be heard the petition of Charles Thornton Ladd for probate of the will of William Mead Ladd, deceased, and it appearing to the court that said William Mead Ladd died at Ojai, California, on the \_\_\_\_\_ day of January, 1931; that at the time of his death and continuously for many years theretofore he had been an inhabitant and resident of the City of Portland, County of Multnomah and State of Oregon, and left an estate therein; that he left a will bearing date the 22d day of November, 1915, which has been filed herein; that Mary A. It is Therefore Now Here Ordered that said will now propounded for probate be, and the same is hereby admitted/probate and proved as, and it is now here decreed to be the Last Will and Testament of said William Mead Ladd, deceased.

It is further ordered that Mary A. Ladd, whom the court finds to be eligible to act as executrix, be and she is hereby appointed as executor of the Last Will of William Mead Ladd, deceased, and that Letters Testamentary be issued to her upon her filing the oath required by law.
