

Lots 1, 3, 5, 6, 7, and 9, the east half of the northeast quarter, the southwest quarter of the northeast quarter, the southeast quarter of the northwest quarter, the east half of the southwest quarter, and the west half of the southeast quarter of Section 26;  
 Lots 4 and 5 of Section 27;

Lots 3 of Section 33; together with all shore lands of the second class abutting thereon;

Lots 1, 2, 6, 7, 8, and 9, the northeast quarter of the northeast quarter, the south half of the northeast quarter, the southeast quarter of the southwest quarter, and the southwest quarter of the southeast quarter of Section 34, together with all shore lands of the second class abutting on said Lots 7, 8, and 9; EXCEPT that portion of said Lot 9 and of the southeast quarter of the southwest quarter bounded and described as follows:

Beginning at the southwest corner of said section; thence north, along the west line thereof 342.69 feet; thence north 35° 46' east 1234.95 feet to the north line of the south half of the southwest quarter; thence east along said north line 1258.84 feet; thence south 0° 11' 33" east 1333.95 feet to the south line of said Section 34; thence west along said south line 1983 feet to the point of beginning;

Subject to all rights of way for county roads now located and used over and across said premises.

A-1 Item 3: Lands in Township 6 North, Range 3 East of Willamette Meridian:

Lots 7, 8, 9, 10, and 11, and the southeast quarter of the southeast quarter of Section 19;

Lots 3 and 4 of Section 20;

Lots 5, 6, and 7 of Section 26;

Lots 4, 5, 9, 10, and 11, and the southwest quarter of Section 27;

Lots 3, 4, and 7, the southwest quarter of the northwest quarter, the northwest quarter of the southwest quarter, the east half of the southwest quarter, the northwest quarter of the southeast quarter and the south half of the southeast quarter of Section 28;

Lots 4, 5, and 6, the northwest quarter of the northwest quarter, and the south half of the northwest quarter of Section 29;

Lot 2, and the north half of the northeast quarter of Section 30, and all of those parts of Lot 1 and of the northeast quarter of the northwest quarter of said Section 30 which lie below the 350 foot contour as established from the United States Geological Survey, mean sea level datum;

The northwest quarter of the northwest quarter of the northeast quarter, and the north 500 feet of the northwest quarter of Section 34;

Lot 1, the northwest quarter of the northeast quarter, the south half of the northeast quarter, the north half of the northeast quarter of the northwest quarter, and the northeast quarter of the northwest quarter of the northwest quarter of Section 35;

Lots 4, 5, 8, and 9, and the southwest quarter of the northwest quarter of Section 36, EXCEPT the south 100 feet of said Lot 5;

SUBJECT to all rights of way for county roads now located and used over and across said premises.

A-1 Item 4: Lands in Township 6 North, Range 4 East of Willamette Meridian:

That part of Section 3 lying southeasterly of the center of the channel of Lewis River; together with all shore lands of the second class abutting thereon;

Those portions of the east half of the southeast quarter of Section 4, lying east of the center of the channel of Lewis River; together with all shore lands of the second class abutting thereon; The southeast quarter of the northeast quarter, and the east half of the southeast quarter of Section 9, ALSO, those portions of the north half of the northeast quarter, the southwest quarter of the northeast quarter, the south half of the southwest quarter, and the west half of the southeast quarter of said Section 9, lying east of the center of the channel of Lewis River; together with all shore lands of the second class abutting on said lands in Section 9;

Lots 3 and 4, and the south half of the southwest quarter of Section 10;

All of the northeast quarter, the southeast quarter of the northwest quarter, and the northeast quarter of the southwest quarter of Section 16; ALSO that portion of the west half of the southwest quarter of said Section 16, lying east of the center of the channel of Lewis River; together with all shore lands of the second class abutting on the northwest quarter of the northeast quarter, and on said portion of the west half of the southwest quarter of said section;

That part of the northeast quarter of the northeast quarter of Section 17 lying easterly of the center of the channel of Lewis River; together with all shore lands of the second class abutting thereon;

The northeast quarter of the southeast quarter, and the south half of the southeast quarter of Section 21; ALSO, those portions of the east half of the northwest quarter, the east half of the southwest quarter, and of the northwest quarter of the southeast quarter of said Section 21, lying east of the center of the channel of Lewis River; together with all shore lands of the second class abutting on the southwest quarter of the southeast quarter, and on said portions of the northeast quarter of the northwest quarter, the east half of the southwest quarter, and of the northwest quarter of the southeast quarter of said section;
