

second class abutting on said portions of the northeast quarter of the northwest quarter, the east half of the southwest quarter, and of the northwest quarter of the southeast quarter of said section;

That portion of the northwest quarter of the southwest quarter of Section 28, lying west of the center of the channel of Lewis River, together with all shore lands of the second class abutting thereon;

The northeast quarter of the northeast quarter, and the south half of the northeast quarter of Section 31; ALSO, those portions of Lot 2, the southeast quarter of the northwest quarter, the northeast quarter of the southwest quarter, and of the north half of the southeast quarter of said Section 31, lying north of the center of the channel of Lewis River;

Those portions of the northeast quarter of the northeast quarter, the southwest quarter of the northeast quarter, and of the north half of the southwest quarter of Section 32, lying northwesterly of the center of the channel of Lewis River; ALSO, that portion of the northwest quarter of said Section 32, bounded and described as follows:

Beginning at a point on the eastern boundary line of the northwest quarter of Section 32, Township 6 North, Range 4 East of Willamette Meridian, south 0° 01' east and a distance of 1357 feet from the northeast corner of said northwest quarter of said section; thence south 35° 12' west 134 feet; thence in a southwesterly direction along the arc of a 20° curve to the right 130 feet; thence south 61° 16' west 547 feet; thence in a southwesterly direction along the arc of a 16° curve to the left 113 feet; thence south 49° 57' west 28 feet; thence in a southwesterly direction along the arc of a 12° curve to the right 108 feet; thence south 62° 57' west 19 feet; thence in a southwesterly direction along the arc of an 8° curve to the left 219 feet; thence south 45° 25' west 21 feet; thence in a southwesterly direction along the arc of a 24° curve to the right 159 feet; thence south 83° 28' west 78 feet; thence in a southwesterly direction along the arc of a 10° curve to the left 151 feet; thence south 68° 22' west 62 feet; thence in a southwesterly direction along the arc of a 10° curve to the right 219 feet; thence north 89° 44' west 185 feet; thence in a southwesterly direction along the arc of a 20° curve to the left 71 feet; thence south 75° 59' west 6 feet; thence in a northwesterly direction along the arc of a 30° curve to the right 377 feet; thence north 8° 59' east 67 feet; thence in a northeasterly direction along the arc of a 20° curve to the left 80 feet; thence north 7° 06' west 236 feet; thence in a northwesterly direction along the arc of a 24° curve to the left 176 feet; thence north 49° 21' west 217 feet; thence in a northwesterly direction along the arc of a 24° curve to the right 202 feet; thence north 0° 51' west 414 feet; thence in a northwesterly direction along the arc of a 30° curve to the left 114 feet to a point on the west line of said northwest quarter of section 32, which point is 678 feet south of the northwest corner of said section; thence south along the west line of said northwest quarter of said section, 1884 feet to the southwest corner of said northwest quarter; thence east in a direct line along the southern boundary line of said northwest quarter to the center of said section; thence north 0° 01' west along the eastern boundary line of said northwest quarter of said section 1087 feet to the point of beginning;

Also, a strip of land outside of and adjacent and parallel to the northerly boundary of the tract described immediately above, said strip being 30 feet in width measured at right angles to the said northerly boundary, and to the prolongations of said northerly boundary where it intersects the east and west lines of the northwest quarter of said section, the northerly boundary of said strip terminating at the east and west line of said northwest quarter.

A-1 Item 10: Lands in Township 7 North, Range 4 East of Willamette Meridian:

Lots 3 and 4, the southwest quarter of the northwest quarter, the west half of the southwest quarter, and the south half of the southeast quarter of the northwest quarter of Section 26; together with all shore lands of the second class abutting on said Lots 3 and 4; ALSO, a parcel of land in said Section 26, bounded and described as follows:

Beginning 100 rods from the east line of the Joseph Masters Homestead Claim in said section; running west at the foot of the bench and first flat land, and thence in a southerly direction to lands formerly owned by J. W. Robbins; thence along said J. W. Robbins line to the Lewis River; thence along the Lewis River 66 rods; thence in a northwesterly direction past a bunch of cherry trees to the place of beginning, to a fir tree and large spring.

Beginning at a point on the westerly line of the Lewis River road revision, said point being 510.9 feet south and 300.4 feet west of the quarter section corner common to Section 33 and 34, Township 7 North, Range 4 East of the Willamette Meridian; thence west 167.7 feet; thence north 272.6 feet; thence east 300 feet to the westerly line of the right of way of said Lewis River road; thence southwesterly along said westerly line of the right of way along a curve to the left having a radius of 2895 feet through an angle of 6° 00', a distance of 303.2 feet to the point of beginning.
