Lands in Umatilla County, State of Oregon:

- A-6 Item 1: Those portions of the west half of Section 16, Township 4 North, Range 28
 East of Willamette Meridian, described as follows:
 - (a) The north half of the southwest quarter of the northwest quarter;
 - (b) The south half of the southeast quarter of the northwest quarter;
 - (c) That portion of the north half of the southeast quarter of the northwest quarter lying southwesterly of the northeasterly bank of Umatilla River, including the islands in said river;
 - (d) That portion of the east half of the southwest quarter lying westerly of the Umatilla River, including the islands in said river.
- A-6 Item 2: That portion of the southwest quarter of the northeast quarter of Section 16, Township 4 North, Range 28 East of Willamette Meridian, bounded and described as follows:

Beginning at the center of said section; thence north 417.6 feet; thence east 208.8 feet; thence south 417.6 feet; thence west 208.8 feet to the point of beginning, containing 2 acres, more or less.

A-6 Item 3: That portion of the south half of the southwest quarter of the northwest quarter of Section 16, Township 4 North, Range 28 East of Willamette Meridian, described as follows:

A strip of land 60 feet in width, the southerly line of which begins at a point on the north line of said subdivision 387.1 feet west of the northeast corner thereof; thence south 76° 59' west 123.7 feet; thence south 80° 34' west 164.8 feet to a point 57.4 feet south of the northwest corner of the southeast quarter of the southwest quarter; thence south 80° 34' west 138.6 feet; thence south 86° 22' west 111.4 feet; thence north 86° 16' west 85.1 feet; thence north 49° 30' west 81.7 feet; thence north 30° 35' west 37.1 feet to a point on the north line of the south half of the southwest quarter of the northwest quarter 250.5 feet east of the northwest corner thereof.

- A-6 Item 4: Those portions of the southwest quarter of the southwest quarter of Section 16, Township 4 North, Range 28 East of Willamette Meridian, bounded and described as follows:
 - (a) Beginning at a point on the south line of said section, 750 feet east of the southwest corner thereof; thence north 220 feet; thence east 100 feet; thence south 220 feet; thence west 100 feet to the point of beginning.

 (b) A strip of land 60 feet in width, being 30 feet in width on each side of the center line, of a canal or ditch, described as follows:

A-6 Item 5: That portion of the southeast quarter of the southwest quarter of Section 16,
