This Indenture, Made this 1st day of December 1932, by and between Charles Ziegler and Luella I. Ziegler, husband and wife, parties of the first part and Skamania County Game Commission, of Skamania County, Washington party of the second part, witnesseth:

That the said parties of the first part, for and in consideration of the sum of one dollar to them in hand paid by the party of the second part, the receipt whereof is hereby confessed, do by these presents, remise, release, convey and quit-claim unto the said party of the second part, the following described real property in Skamania County, Washington, to-wit:

Beginning at a point 116 feet southerly from the northwesterly corner on the westerly line of the D. F. Bradford D. L. C. in Section 11, Twp. 2 N. R. 7 E. W. 1 E., said point being at the intersection of the westerly line of the said Bradford D. L. C. and the south boundary line of State Highway No. 8 (as located prior to March 16, 1927, running thence southeasterly on the westerly line of said Bradford D. L. C. 350 feet to the intersection of said line with said highway, thence following the inside boundary of the curve of said State Road No. 8 to the point of beginning, containing one half acre, more or less. Subject, however, to any easements or rights of way which may have heretofore been granted to the Northwestern Electric Company, or to Skamania County or to the State.
